HOW IT ALL WORKS

- Items can be delivered during regular store hours. No appointment necessary. www.RockHallMarine.com or call 410-928-7667 for hours.
- Your items must be marine/nautical related and in clean, good working condition. Manuals are really important. If you still have the original, please bring it. If not, please print a copy from the manufacturer's website and bring it with the item.
- Please complete, sign and date the front of the consignment agreement, your signature means you have read and agree to all terms and conditions of this Agreement. A Consignor Account Number will be assigned to you.
- If possible, please complete the Consignment Inventory sheet prior to item drop-off. Include your Consignor Account Number (if you have one already) and original purchase price of item(s) if known (this will help us to establish the current value of the item).
- You, the consignor will receive 50% of the selling price.
- Consignment Payouts will be made on or about the first week of every month. You will be notified via email if you have a payout waiting.
- Consignors have the following options for Payouts: Cash (\$20 or less), Check (\$20 or more), Gift Certificate, Store Credit, Donation to a RHMC established charity of your choice.
Donation: RHMC has agreements with a number of local organizations, non-profits and charities. You can choose to donate your Payout directly to the group of your choice. If your favorite organization is not a part of our program, please ask a representative of the organization to contact us so that we can add them.

TERMS

1. I hereby warrant that I have complete title/ownership to the items listed and I will not hold Rock Hall Marine Consignment, Inc, responsible for any claim of title or ownership.
2. It is at the sole discretion of RHMC to accept or reject any item offered for consignment sale.
3. If any item is to be sold for parts, it must be represented as a Parts Item at time of drop-off.
4. Value is established at the sole discretion of RHMC management.
5. Should an item(s) be deemed to have no value at the time of initial inspection, the Consignor will be notified via e-mail and will have fifteen (15) days to reclaim their item(s), after which time it will be disposed of without further notice.
6. The consignment period for all items begins at the date consigned items are offered for sale. All accepted items have an 18-month consignment period and allow for a possible price reduction in the amount of 25% at the end of the first Six (6) Months, and another 25% at the end of Twelve (12) Months. RHMC reserves the right to markdown an item at these consignment periods without notice to the Consignor.
7. Any item reclaimed earlier than One-Hundred-Twenty (120) days will be charged a Withdraw Fee of 10% of the item's For Sale value. The Withdraw Fee will be a maximum of One-Hundred-Fifty Dollars (\$150.00)
8. Any item remaining thirty (30) days after the end of the Consignment Period will be considered abandoned and as such will become the property of RHMC.
9. All items will be displayed for sale in the RHMC store located at the Rock Hall Clam House. It is at the sole decision of RHMC to also place an item on the RHMC website for online sale.
10. RHMC will from time-to-time offer sales/discounts to customers. Consignors agree to offer their items during this sale/discounted period. Any item sold during this period will reflect the final sale/discounted price in the Consignor's Payout.
11. Consignors will be notified via email of any payouts due them. Payouts in the form of Check, Cash or Gift Certificate will be held at the store and will be the responsibility of the Consignor to make arrangements for pick-up. Consignor's choosing Mail Check will receive checks as soon as they are ready.
12. It is the Consignor's responsibility to update his/her address, phone number, and email should it change.
13. **RHMC is not liable for the loss, damage or theft of any items placed on consignment. RHMC is not liable for any items lost or damage do to unforeseen and uncontrollable events such as but not limited to earthquake, hurricane, flood and/or fire.**
